



# Liability Release Form

I HEREBY ACKNOWLEDGE AND AGREE that the sport of indoor rock climbing and the use of the facilities of HANGAR 18 INDOOR CLIMBING GYM, LLC. a California Corporation (herein after referred to as Hangar 18), its climbing wall and other training facilities, has inherent risks. I have full knowledge of the nature and extent of all the risks associated with indoor rock climbing and the facilities, and have had any questions about the same explained to me, including but not limited to:

1. All manner of injury resulting from falling off the climbing wall and hitting rock faces and projections whether permanently or temporarily in place, or the floor.
2. Rope abrasion, entanglement and other injuries resulting from activities on or near the climbing walls such as, but not limited to, climbing, belaying, lowering on rope, and any other rope techniques.
3. Injuries resulting from falling climbers or dropped items, such as, but not limited to, ropes, climbing hardware, and dropped or broken holds.
4. Cut and abrasions resulting from skin contact with the climbing wall
5. Failure of ropes, slings, bolts, chains, climbing hardware, anchor points, or any part of the climbing wall structure.

I further acknowledge that the above list is not inclusive of all possible risk associated with the use of Hangar 18 and that the above list in no way limits the extent or each of this waiver and covenant not to sue, I choose to use Hangar 18's climbing facilities and equipment, and agree as follows:

To waive and release any and all claims that I have or may have in the future against Hangar 18, including their owners, operators, employees, agents, and representatives, as well as the designers, manufacturers or installer of the climbing wall or equipment. \_\_\_\_\_ (initial here)

In consideration of my use of Hangar 18, I, the undersigned user, agree to use the Hangar 18 in accordance with its established safety policies and procedures and agree to INDEMNIFY AND HOLD HARMLESS Hangar 18, its officers, agents, owners, and employees from any and all cause of action, claims, demands, losses or costs of any nature whatsoever arising out of or in anyway relating to my use of Hangar 18, whether asserted by the Hangar 18, or any 3rd parties who may be injured on account of or in any way relating to the Hangar 18. \_\_\_\_\_ (initial here)

This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in event of my death. \_\_\_\_\_ (initial here)

By signing this agreement, I waive my right to bring a court action to recover compensation or obtain any other remedy for any injury to myself or my property or for my death, however caused, arising out of my use of the facilities of Hangar 18, now or any time in the future, whether caused by the Gym's negligence or that of its officers, agents or employees. \_\_\_\_\_ (initial here)

I agree to pay for all legal fees accumulated by Hangar 18, incurred by any claims made by me or on my behalf. \_\_\_\_\_ (initial here)
